Lancaster County, Pennsylvania Tax Lists Conestoga Township tax return levied 8-5-1757 with Martin Kendrick, collector, included the names of Jacob RUBLEY, John - Abraham - Ulrich MILLER, Adam MYRE, Samuel & Jacob MYRES, Dinis McMAHON, FREEMAN listed Abraham & Christian STONER, Christian MARTIN, Rudy MILLER. Earl Township assessments 1756 listed Rudy STONER, collector, who had 200 acres; Christian HILDEBRAND 50 acres; Conrad HILDEBRAND 100 acres; Michael HILDEBRAND 80 acres; David MARTIN 200 acres; Martin MARTIN 50 acres; Alexander MARTIN 50 acres; Henry MARTIN 150 acres. Manheim Township Provincial Tax 1756 listed Abraham STONER 12s 6d. Donegal 1757 listed Christian FUCHS, Alex & James LOWRY, Christian MARTIN, Christian & Jacob EBERSOL, Jacob ESSLER, John CAPP, John ETTER, PETER REASER, Casper SHELL, Coble, Allisons, Wilsons.

Though Caspar MIER'S last Will and Testimony was filed in 1771 Frederick Co., Maryland along with his selling of most of his property (except for the tracts he leaves to his son "Henry" and to his daughter and her husband) Caspar's actual last land transaction occurs in 1772 when Caspar MYER transferred his original 273 acres called "Long Acres" to Jacob PENCE (BENTZ). His son Christoph acquired the original Joseph BRUNNER property from Elias BRUNNER in 1771 known as "Barrens". This property changed hands prior when in 1767 it went from John STONER to HENRY STONER.

Caspar MIER served in the Frederick County, Muster Rolls ca 1757 for 42 days. The Muster was under the command of "Captain Stephen RANSBERGER" and the list of other men in his group are as follows: CAPT. STEPHEN HANSBERGER'S MUSTER ROLL included: Henry FOUT; Jacob FOUT; Balser FOUT; Jacob HAVENER; Frederick HAVENER; Moses HICKLE; George JUDEY; Peter MIRE; Peter HANSBERGER Adam HANSBERGER; Melchoir STONER.

Revolutionary War Soldiers of Western North Carolina Burke Co. Vol. 1 by Emmett R. White listed that HENRY STONER, Isaac & Thomas MARTIN, Greenberry, James, John, Spencer WILSON, Conard HILDEBRAND were Loyalists of the American Revolution and all but a few had to appear in court in 1782 to show cause as to why their property should not be confiscated for being disloyal to the American Cause. He also stated that one cannot say that they were either Loyalist or Patriot as they served both sides. The North Carolina Roster of Soldiers in the Revolution page 558 listed #1936 HENRY STOMER page 248 Warrenton 1786 claimed by William Faircloth. Tennessee Genealogical Records of Early Settlers from Tennessee by Whitley listed HENRY STONER receiving warrant #2323 for 1000 acres & listed as a soldier under label 1785-1790 Martin Armstrong's office in a list of military land warrants CLAIMED BY Philip Phillips & Michael Campbell. Lists of Stray Delivered to Samuel Greenlee 1777-1783 included Henry STONER. Later he brought land and McDowell did a survey for him in 1778. This is in Rev. War Papers CR. 14.103 1777-1783, loose papers

Burke Co. was formed 1777 from Rowan County, & the 1778 tax list included Robert-Greenberry-Michael-James & Samuel WILSON, HENRY & JACOB STONER, JACOB STEINER, miller, signed a petition in August of 1778 presented to the General Assembly of Hillsboro, North Carolina stating that in 1734-5-6 a number of their faith, mostly natives of Moravia, had settled in Georgia and when the war broke out with the Spainards they retired to Pennsylvania and settled in the Forks of the Delaware . About 1748 they received invitations to settle in North Carolina [ref. North Carolina Legislative Papers Folder 14, 15 August 1778].

Mr. Scott A. Oxford, curator of the North Carolina room in Burke Co. Public Library stated in a letter dated 6 April 1984 that in 1865 all of the deeds and all but a couple of dozen wills were destroyed although some records did survive. Burke Co. North Carolina records in September of 1778 HENRY STONER entered 300 acres on the North side of the Catawba River 3/4 mile below the horse ford beginning at Laurell Spring.

The 1790 residence was to begin in August & end by May of 1791. Some of the censuses seem to have been taken in the year following the date set for them. The man, whom other records show under 45 in 1790 may have been listed as over 45 in the residence . Page 107 Burke County, 2nd Co. HENRY STONER has 3 males over 16, 2 males under 16 and 7 females with neighbors Jacob & Michael Derryberry, James - Isaac - Thomas MARTIN, John SHELL, Michal HART, SHERWOOD BOON & others. In 1790 Burke Co. included parts of what became Madison, Buncombe, McDowel, Yancey, Mitchell, Avery, Caldwell & Alexander. At that time Burke County, adjoined what was Greene County, TENNESSEE.

In April of 1791 the Jury ordered to view & mark a road from South Branch of Catawba River through Island Ford [last marked out], at the hoorse ford into the road on top of hill on North side of river on Horse Ford Road. Jury: John Barnhart, William & John Connelly, James Moore, Andrew Baird, John GIBB, Henry STONER, Jacob DEBERRY, Michael HART, Zadock & Daniel SMITH & JAMES MARTIN. In October of 1791 Michael Hart came into court as supervisor of the horseford & returned Christian Shell & Jacob STONER to serve this for me. Christian Shell ordered as overseer in place of Michael Hart from "the Devils Holen to the Iron Works". In February 1793 the jury views land from Big Shoals on Gunpowder, by the name of Spencer's Mill, 3,000 acres for Iron Works to be built by Beard & Cobb; John & Hugh Connally, Abner Smally, Frederick & John Grider, John McDANIEL, HENRY STONER, John Spencer Sr, William Sherrell, James Moore, Jacob DEBERRY, Charles Pierce, Michael Grindstaff, Thomas SCOTT, John Barnhart [ref. Burke Co. Land Records 1779-1800 & Important Misc. Records 1777-1800 Vol. II by Huggins]. The 1800-10 residence were to begin in August & end by May of the following year. But, again many were in the year after the date set. By 1800
